The Gary Sanitary District (GSD) is inviting qualified bidders to submit sealed bid proposals for goods and services specified in Contract Documents for Sodium Bisulfite. Contract Documents may be obtained from Timothy Alston at talston@garysan.com upon request.

Sealed bids will be received at the administrative offices of the Gary Sanitary District, 3600 West Third Avenue, Gary, Indiana 46406 until the project agenda item is called by the Board of Commissioners (Board) at the March 21, 2025 Board Meeting. When the project agenda item is called by the Board, the time for submittal of all bids will be closed and bids will be publicly opened and read. The GSD Board meeting is scheduled to begin at 12:00 PM local time.

The project includes goods and services relative to the procurement and delivery of 38% sodium bisulfite to be used for the de-chlorination of chlorinated plant effluent flow prior to discharge into the Grand Calumet River. De-chlorination must remove any residual chlorine from the plant effluent flow in compliance with the NPDES permit.

Each bid must be accompanied by a certified or cashier's check on a solvent bank or trust company, drawn to the order of the Gary Sanitary District, or an acceptable Bid Bond, in an amount of not less than five percent (5%) of the total bid. This sum guarantees that if the bid is accepted, a contract will be entered into and its performance properly secured.

The complete set of forms as specified in the Contract Documents must be returned in its entirety in a sealed envelope along with the appropriate Bid Bond, Certified Check, or Cashier's Check to the Gary Sanitary District. The sealed envelope should be clearly marked on the outside: **SEALED BID: SODIUM BISULFITE March 21, 2025.**



The award of the contract will be made by GSD to the responsible bidder submitting the lowest responsive bid which is in the best interest of GSD. Only qualified bidders will be considered for award. GSD may reject any and all bids.

Instructions to Bidders

- A. General – Gary Sanitary District (GSD) is inviting qualified bidders (BIDDER) to submit Bids for goods and services relative to the procurement and delivery of Sodium Bisulfite (NaHSO₃). Responsible BIDDERS shall be determined by the evaluation of the responsiveness of the CONTRACT DOCUMENTS Bid Proposal Form (Proposal) that is submitted as required herein.
- B. Product Use – The NaHSO₃ is to be used for the de-chlorination of chlorinated plant effluent flow prior to discharge into the Grand Calumet River. De-chlorination must remove any residual chlorine from the plant effluent flow in compliance with the NPDES permit. Residual chlorine in the plant effluent is typically in the 0.1 to 1.0 mg/L range.
- C. Product Specifications - NaHSO₃ shall be a 38% solution of the highest attainable purity, suitable for drinking water treatment, and able to meet any pertinent AWWA, NSF 60, and 327IAC 8 standards for drinking water. The NaHSO₃ shall not cause any abnormal difficulty in operation of chemical feeders designed for the utilization of a 38% NaHSO₃ solution. The BIDDER shall provide the GSD with a copy of the appropriate Safety Data Sheet along with this Bid or prior to the first shipment. GSD shall entertain Bids from each qualified BIDDER for the delivery of NaHSO₃, which has been laboratory tested and meets the specifications identified herein. The NaHSO₃ must meet the requirements of this specification in order to be accepted by the GSD.
- D. Product Performance – In the event that the performance of the product declines and/or the required product dosage increases to a level that is unacceptable to the Gary Sanitary District, the successful BIDDER shall make every effort to improve such performance within 48 hours of notification. Any product substitution suggested by the incumbent supplier must be done at the unit price in effect at the time. If the BIDDER fails to return the product back to performance levels comparable to that of the baseline performance within ten (10) calendar days for the first notification, the GSD, at its sole discretion, may cancel the agreement and secure an alternative product from another source. Recurring problems are grounds for the cancellation of the supply agreement, at the sole discretion of the GSD.
- E. Performance Bond – The successful BIDDER shall provide a Performance Bond in the amount of the estimated annual purchase value calculated based on the Bid price and the estimated annual quantities in section “H”.
- F. Certification of Compliance – BIDDER certifies that all product supplied will meet specifications in section “C” and that all product supplied is consistent in every respect to the material which was approved for use by GSD. BIDDER shall provide GSD with a Certificate of Analysis with every delivery.
- G. Future Testing – GSD reserves the right to test products manufactured by others during the term of the intended contract. GSD shall have the right to purchase products from others as part of its continuous improvement effort and in order to evaluate NaHSO₃

performance with respect to existing or future procurement plans. Such testing of products manufactured by others shall not invalidate the terms and conditions set forth in the Bid.

- H. Estimated Quantities – The estimated annual NaHSO₃ demand at GSD is 150,000 gallons based on 2024 usage. However, no minimum amount of NaHSO₃ purchase is guaranteed. GSD reserves the right to purchase more or less than the estimated quantity without affecting the unit price. GSD shall pay for the actual quantity of product ordered and received at the unit price stipulated in this Bid. BIDDER should be familiar with the NaHSO₃ storage and handling at GSD and should note that the bulk storage capacity at GSD is two 5,000-gallon tanks for a total of 10,000 gallons.
- I. Interruption of Services – During the term of the intended contract or any extension, thereof, in the event that any situation arises which may cause the BIDDER to suspend or interrupt the delivery service of NaHSO₃, the BIDDER shall be responsible for making arrangements for an alternate means of supply and delivery of the product in sufficient quantity to ensure continued operations at the GSD. All costs incurred by the BIDDER for arranging alternate means of supply and delivery shall be the sole responsibility of the BIDDER with no additional costs to the GSD.
- J. Delivery Terms – Goods and Services will be delivered FOB Destination at Gary Sanitary District, 3600 West 3rd Avenue, Gary, IN 46406. Deliveries shall be made between the hours of 7:00 AM and 3:00 PM Monday through Saturday, and within four (4) calendar days of notification of the requirement by the Director of Operations, Plant Engineer, or any other assigned designee. Notification may be by telephone or email. Should there be any delay in obtaining NaHSO₃ from the BIDDER, for any reason, GSD reserves the right to secure it from an alternative source without waving or voiding any terms or conditions of this Bid. BIDDERS should understand that it may be difficult to time shipments to avoid delays in unloading. GSD will make every effort to coordinate orders and deliveries so as to minimize unloading delays. Nonetheless, all related costs shall be included in the unit price of the product. The successful BIDDER shall arrange appropriately for transportation and unloading equipment.
- K. Technical Service and Training - BIDDER agrees to provide a qualified representative upon the request of the Director of Operations, for a minimum of four (4) hours per 12 (twelve) month period throughout the term of the intended contract, for the training of operations and maintenance personnel in the safe handling and use of NaHSO₃. The training duration shall comprise, at the minimum, two (2) two-hour morning sessions to accommodate day shift operators and two (2) two-hour afternoon sessions to accommodate night shift operators. No separate payment shall be made to BIDDER for any training or technical services. All costs for such services shall be included in the Bid price.
- L. Award – GSD will determine the responsible BIDDER that submits the lowest responsive Bid which is in the best interest of GSD. GSD may reject any and all Bids or any item

or items bid. A Notice of Award and Purchase Agreement will be sent to the successful BIDDER within 15 days after the approval of the Bid Award by the GSD Board of Commissioners. The Purchase Agreement must be signed and returned to GSD within 5 days of receipt by BIDDER. The Agreement is executed upon signatures of both BIDDER and GSD.

- M. Duration of Agreement(s) – It is the intent of GSD to enter into a requirements-type agreement with the successful BIDDER for a period of one (1) year from the date of execution. The price shall remain firm for the initial one year term. Upon mutual acceptance of both parties, this agreement may be extended for up to two (2) separate and consecutive, one-year periods, provided there is no increase in price from the initial agreement entered into as a result of this Bid.
- N. Bid Bond – Each Bid must be accompanied by a certified or cashier’s check on a solvent bank or trust company, drawn to the order of Gary Sanitary District, or an acceptable Bid Bond, in an amount of not less than five per cent (5%) of the total bid. This sum guarantees that if the bid is accepted, a contract will be entered into and its performance properly secured. Moreover,
- N.1 BIDDER and Surety, jointly and severally, bind themselves, their heirs, executors, administrators, successors and assigns’ to pay to GSD upon default of BIDDER the penal sum set forth on the face of this Bond.
 - N.2 Default of BIDDER shall occur upon the failure of BIDDER to deliver within the time required by the Contract Documents (or any extension thereof agreed to in writing by GSD) the executed Agreement required by section “L” and any performance bond.
 - N.3 This obligation shall be null and void if:
 - N.3.1 GSD accepts the BIDDER’s Bid and BIDDER delivers within the time required by the Contract Documents (or any extension thereof agreed to in writing by GSD) the executed Agreement required by the Contract Documents and any performance and payment bonds required by the Contract Documents, or
 - N.3.2 All Bids are rejected by GSD, or
 - N.3.3 GSD fails to issue a Notice of Award to BIDDER within the timeframe specified in section “L” or any extension thereof agreed to in writing by BIDDER.
 - N.4 Payment under this Bond will be due and payable upon default by BIDDER and within thirty (30) calendar days after receipt by BIDDER and Surety of written notice of default from GSD, which notice will be given with reasonable promptness, identifying this Bond and the Project and including a statement of the amount due.
 - N.5 Surety waives notice of any and all defenses based on or arising out of any time extension to issue Notice of Award agreed to in writing by GSD and BIDDER, provided that the total time for issuing Notice of Award including extensions shall

not in the aggregate exceed 120 days from Bid due date without Surety's written consent.

- N.6 No suit or action shall be commenced under this Bond prior to thirty (30) calendar days after the notice of default required in paragraph L.3.4 above is received by BIDDER and Surety and in no case later than one (1) year after Bid due date.
- N.7 Any suit or action under this Bond shall be commenced only in a court of competent jurisdiction located in the state in which the Project is located.
- N.8 Notices required herein shall be in writing and sent to BIDDER and Surety at their respective addresses shown on the face of this Bond. Such notices may be sent by personal delivery, commercial courier or by United States Registered or Certified Mail, return receipt requested, postage pre-paid, and shall be deemed to be effective upon receipt by the party concerned.
- N.9 Surety shall cause to be attached to this Bond a current and effective Power of Attorney evidencing the authority of the officer, agent, or representative who executed this Bond on behalf of Surety to execute, seal and deliver such Bond and bind the Surety thereby.
- N.10 This Bond is intended to conform to all applicable statutory requirements. Any applicable requirement of any applicable statute that has been omitted from this Bond shall be deemed to be included herein as if set forth at length. If any provision of this Bond conflicts with any applicable statute, then the provision of said statute shall govern and the remainder of this Bond that is not in conflict therewith shall continue in full force and effect.
- N.11 The term "Bid" as used herein includes a Bid, offer or proposal as applicable.
- O. Price – The unit price (\$/gallon), shall include all charges for Goods and Services, FOB Destination to the GSD WWTP, 3600 West 3rd Avenue, Gary, Indiana, 46406. GSD will make every effort to handle material in bulk and to receive full tank truck shipments. All costs associated with shipping and handling shall be included in the unit price bid. GSD will not be responsible for any additional handling charges. NaHSO₃ purchased by GSD is free of federal and state sales tax.
- P. Cancellation of Agreement (s) – GSD may terminate this agreement at any time, for any reason, by giving at least 30 days' notice in writing to the supplier. If the agreement is terminated by GSD as provided herein, the supplier will be paid for all NaHSO₃ ordered and received by GSD.
- Q. Bid Closing Date – Sealed Bids for the GSD WWTP goods and services relative to the procurement and delivery of NaHSO₃ will be received at the Administrative Offices of the GSD until the project agenda item is called by the Board of Commissioners (Board) at the Friday, March 21, 2025 Board Meeting. The sealed envelope must be clearly marked on the outside "**Sealed Bid; Sodium Bisulfite; March 21, 2025.**" Bids should be returned to:

When the project agenda item is called by the Board, the time for submittal of all Bids will be closed and Bids will be publicly opened and read. The GSD Board meeting is scheduled to begin at 12:00 PM local time. Bids, Amendments to Bids or requests for withdrawal of Bids received after the closing time will not be considered. Bids shall remain in effect for a period of ninety (90) days from the closing date.

R. BIDDER REFERENCES - BIDDER shall provide a minimum of three (3) references of current municipal customers for NaHSO₃ as stated herein. References may be current municipal customers of the BIDDER or of the manufacturer, in the event that the BIDDER is the manufacturer's representative.

S. BIDDER CERTIFICATION – In submitting Bid, BIDDER certifies that:

- S.1 If the Bid is accepted, an agreement will be entered into with GSD to supply NaHSO₃ for the prices and within the times indicated in the Bid and in accordance with all of the other terms and conditions of CONTRACT DOCUMENTS Instructions to Bidders (Instructions).
- S.2 BIDDER has read and understands the Instructions and any Addenda in its entirety.
- S.3 BIDDER has made its own determination of any and all conditions which may affect in any way the performance of goods and services during the entire term of the intended contract.
- S.4 BIDDER is aware of plant operations, which may have an effect on effluent characteristics during the term of the intended contract and BIDDER shall take these conditions into consideration for its BIDDER offering.
- S.5 BIDDER has given GSD written notice of all conflicts, errors, ambiguities, or discrepancies that BIDDER has discovered in the Instructions and the written resolution thereof by GSD is acceptable to BIDDER.
- S.6 The Instructions are generally sufficient to indicate and convey understanding of all terms and conditions for supplying NaHSO₃ for which the Bid is submitted.
- S.7 BIDDER is not in arrears to GSD, upon debt or contract, is not a defaulter, as surety or otherwise, upon any obligation to the GSD, and has not been delinquent or unfaithful in any former contract with the GSD.
- S.8 There is no officer or employee or person whose salary is payable in whole or in part by GSD who is, or shall become interested, directly or indirectly, as a contracting party, partner, stockholder, surety or otherwise, in this Bid.

- S.9 BIDDER has not entered into any combination, collusion or agreement with any person relative to the price to be bid by anyone, this Bid is made without reference to any other bid and without agreement, understanding, or combination with any other person in reference to such bidding, and no person or persons, firms, or corporation has, have, or will receive directly or indirectly, any rebate, fee, gift, commission or thing of value on account of such sale.
- S.10 This Bid is genuine and not made in the interest of or on behalf of any undisclosed individual or entity and is not submitted in conformity with any agreement or rules of any group, association, organization or corporation.
- S.11 BIDDER has not directly or indirectly induced or solicited any other bidder to submit a false or sham Bid.
- S.12 BIDDER has not solicited or induced any individual or entity to refrain from bidding.
- S.13 BIDDER has not sought by collusion to obtain for itself, advantage over any other BIDDER or over GSD.
- T. FALSE STATEMENTS – A false statement willfully or fraudulently made in connection with this Bid, on any of the required forms, may result in the disqualification of BIDDER or the termination of ant agreement between GSD and BIDDER. As a result, the BIDDER may be barred from participating in future GSD bids.
- U. Preparation of the Bid – BIDDERS shall complete the **CONTRACT DOCUMENTS Bid Proposal Form** (Proposal) contained in this Bid Package, in its entirety. Proposals which are, incomplete, obscure, conditional, unbalanced, or which contains additions not called for or irregularities of any kind may be rejected at the discretion of GSD. Proposals not accompanied by the required bid security shall be rejected. Bids shall remain in effect for a period of ninety (90) days from the closing date. Unless a Bid is formally withdrawn prior to the Bid Closing Date, it shall be deemed open for acceptance until an agreement has been executed or until GSD indicates that it does not intend to accept the Bid. Notice of acceptance of any Bid shall not constitute rejection of any other Bid. Proposal forms should be submitted in the following order:
