Heavy Equipment Mechanic (PT) -Gary Stormwater Management District

The incumbent is responsible for inspecting, maintaining and repairing heavy machinery and vehicles used in various departments including Collections department. This includes specialized equipment such as vactor trucks, backhoes, loaders, compactors, refuse trucks, and other GSD/GSWMD vehicles.

Key Responsibilities:

- Perform routine maintenance, including oil changes, lubrication, brake inspections, and tire replacements.
- Maintain and repair sewer line maintenance equipment, such as vacuum trucks and CCTV inspection units.
- Utilize diagnostic tools to identify and resolve equipment malfunctions.
- Maintain accurate service records, parts inventory, and maintenance schedules.
- Weld, fabricate, or modify parts as needed for specialized equipment repairs.
- Operate heavy equipment to test repairs and ensure functionality.
- Adhere to safety guidelines, including proper handling of hazardous materials.
- Collaborate with other departments and provide technical guidance on equipment operation and maintenance.
- Assist in emergency repairs for sewer and drainage system failures
- Ensure compliance with safety and environmental regulations related to waste management equipment.
- Inspect, maintain, and repair refuse trucks, compactors, and roll-off containers.
- Troubleshoot and repair hydraulic and pneumatic systems on trash collection vehicles.
- Performs related duties assigned.

Work Schedule:

- Part-Time position scheduled to work 2-3 days every two weeks. Hours not to exceed 28 hours week
- Flexible scheduling may be required based on emergency repairs or department needs.

• High school diploma or equivalent (technical or vocational training in diesel mechanics, hydraulics, or related field preferred).

Certification:

- Certification from the National Institute for Automotive Service Excellence (ASE) or equivalent is a plus.
- Completion of an OSHA compliance course is required.
- Valid driver's license (CDL preferred).

Skills and Experience:

- Minimum 2-5 years' experience as a heavy equipment mechanic, preferably in municipal services, wastewater, or solid waste management.
- Strong knowledge of diesel engines, hydraulic systems, electrical troubleshooting, and heavy machinery repair.
- Experience with computerized diagnostic tools and repair software.
- Welding and fabrication skills preferred.
- Ability to read and interpret technical manuals, blueprints, and schematics.

Physical Demand and Work Environment:

- Physical ability to lift heavy equipment and work in various weather conditions.
- Work performed in both shop and field settings, including exposure to sewage, chemicals, and hazardous materials.
- Frequent lifting, bending, and working in confined spaces or extreme weather conditions.
- Incumbent regularly works extended hours and occasionally works evenings/weekends, travels out of town for conferences, sometimes overnight, and responds to emergencies on 24-hr basis or from off-duty status.
